

**SUMMARY ANNUAL REPORT  
FOR 401(A) DEF CONT RET PLAN FOR DARTMOUTH COLLEGE  
FACULTY/STAFF**

This is a summary of the Form 5500 Annual Return/Report of Employee Benefit Plan for the 401(A) DEF CONT RET PLAN FOR DARTMOUTH COLLEGE FACULTY/STAFF, EIN 02-0222111, Plan 005, for period January 1, 2023 through December 31, 2023. The Form 5500 annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA). Your plan is a defined contribution, age/service weighted or new comparability, money purchase, ERISA section 404(c), total participant-directed account, Code section 401(m), default investment account, single employer type of plan.

**Basic Financial Statement**

Benefits under the plan are provided through insurance and through a trust fund. Plan expenses were \$30,393,483. These expenses included \$373,084 in administrative expenses and \$30,020,399 in benefits paid to participants and beneficiaries. A total of 7702 persons were participants in or beneficiaries of the plan at the end of the plan year.

The value of plan assets, after subtracting liabilities of the plan, was \$819,806,367 as of December 31, 2023, compared to \$688,171,831 as of January 1, 2023. During the plan year, the plan experienced an increase in its net assets of \$131,634,536. This increase includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$162,028,019, including employer contributions of \$31,975,446, earnings from investments of \$129,770,481 and other income of \$282,092.

**Minimum Funding Standards**

Enough money was contributed to the plan to keep it funded in accordance with the minimum funding standards of ERISA.
